1. Introduction

Our website, https://www.child-world.co.il (hereinafter: "the website") uses cookies and other related technologies (for convenience all technologies are referred to as "cookies"). 2. What are cookies?

3. What are scripts?

A script is a piece of program code that is used to make our website function properly and interactively. This code is executed on our server or on your device.

4. What is a web beacon?

5. Cookies

5.1 Technical or functional cookies
